LWC Investment Options In light of the recent banking industry challenges and the Commission's goal to improve returns of cash-on-hand and reserve funds, F&M Bank Chairman Kent Steinwert gave a presentation to the committee. The committee discussed the recent bank failures and Steinwert assured the committee that the bank was in a strong position and not subject to the problems that arose at the other banks. Additionally, Commission funds are designated as "public funds" and collateralized at 110%. After a constructive conversation, the committee noted that they had already directed staff with consult of Finance Chair to pursue and execute on the best options for the Commission.

- 7. Year-to-Date Budget Review the committee reviewed the year-to-date budget through February 2023 (Exhibit C). Motion to accept the financial statements and budget report as presented. Olagaray/ Sywassink Carried.

- 5. Financial Report the committee reviewed the December 2022 financials (Exhibit B).
- 6. Year-to-Date Budget Review the committee reviewed the year-to-date budget through December 2022 (Exhibit C). Motion to accept the financial statements and budget report as presented through December 2022. Olagaray/ Sywassink Carried.
- 7. LWC Investment Options The committee discussed different options for managing the Commission's cash throughout the year. Cash-on-hand typically peaks around February and reaches its low point around October. Until recently, with near zero interest rates, the best strategy was to leave funds in checking accounts to offset monthly fees. The committee discussed moving some funds to a money market account at Charles Schwab. Current 7-day yields are running at 4.47%. The Commission's current bank is offering 1.5% on money market funds and CD's ranging from 2.0-2.75% for up to 12 months. Motion to reach out to existing bank to see if they can match or come close to rates available at Charles Schwab, and if not, for staff to work with Finance Chair to move funds accordingly. 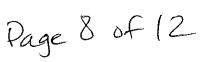

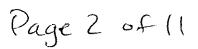
